Price (in cents/kWh) and number of months this price stays in effect	Your price for electricity generation supply will be a variable price, per kilowatt hour, plus taxes and fees, if applicable. Your monthly variable price is based on RPA’s actual and estimated costs of obtaining wholesale electricity supply from the PJM Interconnection (“PJM”) including but not limited to prior period adjustments, inventory and balancing costs. The variable price may change on a monthly basis. There is no cap on your variable price, and there is no limit on how much the price may change from one billing cycle to the next. Your initial electric supply price for your first billing cycle with RPA will be at the utility’s price to compare. Thereafter, your price will be vary month-to-month based on the factors described above.
